#### **DETAILS OF THE DECISIONS TAKEN**


##### **07.01 Approval of minutes of the Sixth Academic Council meeting held on 3<sup>rd</sup> November 2010**

The Academic Council confirmed the minutes of the Sixth Academic Council meeting held on 3<sup>rd</sup> November, 2010.

##### **07.02 To inform the Academic Council of the actions taken on the decisions of the Sixth Academic Council meeting held on 3<sup>rd</sup> November, 2010**

The Academic Council was informed of the actions taken on the decisions of its Sixth meeting held on 3<sup>rd</sup> November, 2010. The council took note of Actions Taken and expressed its appreciation.

- Dr. Anjana Solanki apprised that first issue of University magazine "Vithika" could not be published due to poor response of articles. It was decided that Cultural Council shall conduct a workshop to motivate students for their participation. It was also decided that students shall be encouraged with the involvement of Deans/HoDs of concerned schools to publish the first issue early and ensure its regular and timely publication.

- Dean, Academics informed that admission process for all the new programmes approved by the Council earlier, except B.B.M. + L.L.B, has been initiated. In this context, Prof. N.K. Jain and Dr. Prashant Gupta of School of Management expressed their inability in launching Executive M.B.A. (15 months duration) programme from next session 2011-12 as they have to seek certain clarifications about the acceptability of the duration of the said programme from the UGC and other regulatory bodies. The Chairperson, emphasized that this programme should be started on scheduled time and necessary clarifications from respective bodies be sought immediately. Prof. C.B. Sharma, Member of the Council, was requested to help the Dean, SoM in getting such clarifications in consultation with Dean, Academics. The three member Committee, comprising of the Dean, Academics, Dean, SoM and Prof. C.B. Sharma, may submit its report within a month.

**07.03 To apprise the Academic Council about the RDC held on 23<sup>rd</sup> December, 2010**

**07.04 To apprise the Academic Council about the proceedings of Board of Studies in different Schools**

The Academic Council took notice of the details of various academic programme and course structure as approved by the Board of Studies of School of Management, School of Information and Communication Technology and School of Applied Sciences. The Council approved the same.

**07.05 Any other matter with the permission of the Chair**

The recommendation of the fee structure review committee was placed before the Academic Council with the permission of the Chair which approved the recommendations of the committee to reduce the fee of M.A. programme of the University from Rs. 24000 to Rs. 12000 per academic year. This would be applicable to all M.A. programmes like Development Studies, Education etc.

Fee for MSW programme was also approved as per recommendation of the fee committee i.e. Rs. 24000 per academic year. The revised rate of fees shall be applicable from the forthcoming session (2011-12). The members welcomed this suggestion and approved the same.

Prof. C.B. Sharma requested the council to start M.A. (Education) also from the next session in the light of the growing demand of teachers in the background of implementation of Right to Education Act. After detailed deliberations it was decided to issue advertisement for M.A. (Education) programme with an intake of 30 initially. It was decided that the Dean, Humanities & Social Sciences shall coordinate the implementation of this programme.
