Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and University Grants Commission hereby makes the following amendment in the University Grants Commission other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, namely: section (1) of section 26 read with section 14 of the University Grants Commission Act, 1956 (3 of 1956), the No. F. 9-1/2010(PS/MISC)Pt. Vol. II.—In exercise of the powers conferred under clause (c) and (g) of sub-

- Short title and commencement. (1) These regulations may be called the University Grants Commission Colleges and other Measures for the Maintenance of Standards in Higher Education) (2nd (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Amendment) Regulations, 2023.
- (2) They shall come into force with effect from 1" July, 2023.
- other Academic Staff in Universities and Colleges and other Measures for the Maintenance of In the University Grants Commission (Minimum Qualifications for Appointment of Teachers and Standards in Higher Education) Regulations, 2018, in regulation 3, for sub-regulation 3.10, the following sub-regulation shall be substituted, namely:
- 3.10 "NET/SET/SLET shall be the minimum criteria for the direct recruitment to the post of Assistant Professor for all Higher Education Institutions."

Qualifications for Appointment of Teachers and other Academic Stuff in Universities and Colleges and other As a consequence, in regulation 3, for sub-regulation 3.10, of the University Crants Commission (Minimum Measures for the Maintenance of Standards in Higher Education) (18 Amendment) Regulations, 2021 stands deleted.
